- SET UP IS FRIDAY AT 3PM – NO EXCEPTIONS. THERE WILL BE FIRE MARSHALL AND CHESPROCOTT INSPECTION PRIOR TO EVENT – ALL TRUCKS MUST CARRY A FIRE EXTINGUISHER.**
- OWNERS OF TRUCKS SOLELY RESPONSIBLE FOR TRUCKS LEFT OVERNIGHT**
- Vendors are permitted to leave trucks overnight – the Chamber is not responsible for any equipment left unattended.
